Final payment is due on the date stated on your invoice. **ALL PAYMENTS MADE TOWARDS THE BALANCE WILL NOT BE REFUNDED, AND IT IS NOT TRANSFERABLE.** If traveling with a roommate, please be aware that you will be responsible for the additional cost for Single Occupancy in the event of cancellation and if another roommate cannot be found. JW Trips™ will not be responsible for finding another traveler as a roommate.

Cancellations, Refunds, and Trip Interruptions: Due to the nature of group travel and contracting with service providers, deposits and payments made cannot be refunded. Unused hotel accommodations or any unused features or segments of the purchased tour are **not refundable** or exchangeable for other services. Travel insurance is not included in the tour price and will require a separate purchase.

Cruise Cancellation Policy: (Non-Refundable Deposit) If you cancel your reservation after a specific date, you may be subject to cancellation charges. Please see the cancellation policy for the cruise chosen.

Land Only: If a Land Only package is selected, it will be the responsibility of the traveler to make arrangements to the hotel and to the airport.
